Job J7S2185C: Route 66, Jasper County – Construct pavement, operational improvements, and ADA improvements from Maiden Lane to Route 43 (Main Street) in the city of Joplin, the total length of improvements being 0.985 miles.

Job J7S2185D: Route 66, Jasper County – Construct pavement, operational improvements, and ADA improvements from Route 43 (Main Street) to St. Louis Avenue in the city of Joplin, the total length of improvements being 1.014 miles.

Job J7S2185E: Route 66, Jasper County – Construct pavement and operational improvements from St. Louis Avenue to Loop 49 (Range Line Road) in the city of Joplin, the total length of improvements being 0.956 miles.

Job J7S2185F: Route 66, Jasper County – Construct ADA improvements from Route P (Schifferdecker Avenue) to Maiden Lane in the city of Joplin, the total length of improvements being 0.965 miles.
